- Carry out risk dynamic assessments and consider how risks could be reduced.
- Outline safe operational procedures which identify and take into account all relevant hazards
- Check that policies and procedures are being properly implemented, including the Construction Phase Plan
- Ensure working practices are safe and comply with current legislation
- Record inspection findings and produce reports from site that suggest improvements
- Keep up to date with new legislation and maintain a working knowledge of all Health and Safety Executive (HSE) legislation and any developments that affect the employer's industry
- Attend Institution of Occupational Safety and Health (IOSH) seminars and read professional journals
- Attend project meetings with the client and contractors, where health and safety will be an agenda item

Salary

- Starting salaries for health and safety advisers will be in the region of £24,000 to £32,000. Depending on Skills Knowledge Experience and Training

Working hours

Our working hours are flexible and vary day to day. This is predominantly a field based role (not a desk job), but there will be some amount of working at home required.
